FLINT HILLS RESOURCES NAMES NEW PRESIDENT

WICHITA, Kan. — Flint Hills Resources has named Brad Razook as its president and chief executive officer.

Razook most recently served as the company's executive vice president of supply and marketing, a position he's held since 2002.

"Brad has played an important role in the success of Flint Hills Resources," said Dave Robertson, chairman of the Flint Hills Resources board. "Not only does he have vast knowledge in supply and marketing, but he has also played an important role in the plans for expanding our refining capacity in Minnesota, as well as construction projects aimed at meeting customers' increasing fuel demand in Texas and the Midwest."

"Flint Hills Resources is a company that is committed to creating real value for the long term," Razook said. "I'm honored to have been asked to lead a company that exhibits a strong commitment to the environment, to the health and safety of its employees, contractors and communities, and to helping improve the quality of life in our communities."

Flint Hills Resources has begun an estimated \$200 million project to add about 50,000 barrels per day to its Minnesota refining capacity. In addition, the company also plans to expand fuels terminal capacity in Waco and Austin, Texas, and is building a new fuel storage and distribution terminal near Bastrop, Texas.

Since 2003, Flint Hills Resources has invested in a base lube oils business in Louisiana and acquired Alaska assets, including a refinery in North Pole and associated products terminals. In addition, the company also acquired a chemical intermediates plant near Joliet, Ill. In 2005, the company acquired a system of asphalt terminals that distribute product produced at the Minnesota refinery.

Razook began his Koch company career with Koch Carbon, Inc. in 1985. He moved to Koch Materials Co., Koch's asphalt subsidiary, in 1993, ultimately becoming vice president of supply and distribution.

In 1995, he moved to Calgary, Alberta, with Koch Oil Company, where he became executive vice president. He joined Koch Petroleum Group in 1997 as vice president of Pine Bend marketing, based in Wichita. In this role, Brad managed the light products business for the Minnesota refinery, light products wholesale business in the mid-continent region, and the ethanol businesses. Razook earned a bachelor's degree from Kansas State University. He is a native of Hesston, Kan.

The company operates refineries in Corpus Christi, Texas, North Pole, Alaska, and Pine Bend, Minn., as well as a chemical intermediates plant near Joliet, Ill.
